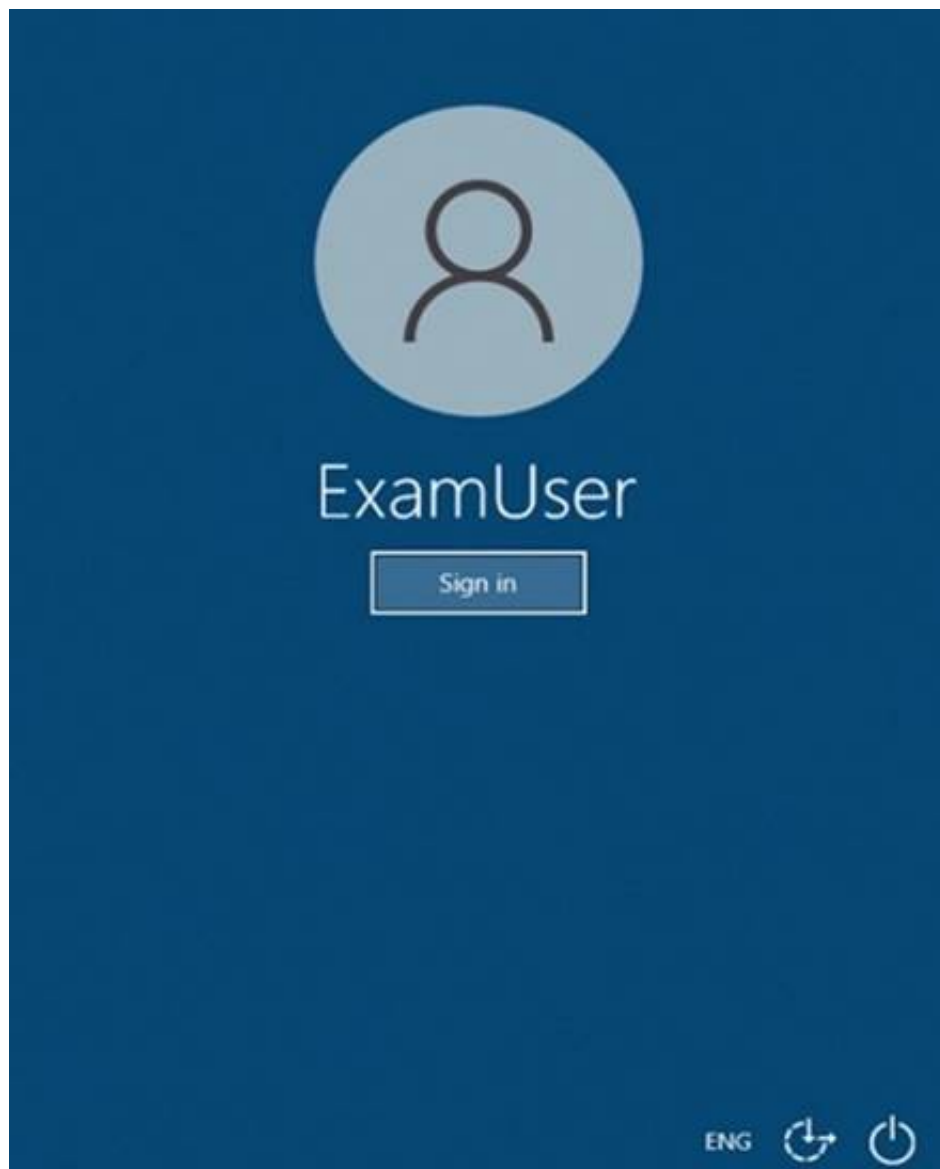

\$true: Email address policies are applied to this recipient. This is the default value.
